Texas Code Review can review & inspect both privately and publicly financed projects. Financed construction projects which are leased to the State or a political subdivision must be applied to TDLR in Austin for review and inspection. The plan review fee includes only one resubmittal review. Our normal expected plan review period is about 10 working days. The Inspection Fee is for one (1) field inspection for projects within a 100-mile radius of Texas Code Review. A Mileage Fee applies to projects that exceed the 100 miles radius from Texas Code Review. Calculate the total miles of travel by \$.50 per mile. Call for inspection travel expenses outside a 100-miles.
